**Directions for Use:** Polish using an air or electric buffer (1400-2000 rpm) equipped with a 3M<sup>TM</sup> Perfect-It<sup>TM</sup> Ultrafina<sup>TM</sup> Foam Polishing Pad.

- 1. Shake container well before using.
- 2. Work small areas, about two by two feet.

<u>IMPORTANT</u>: This product is designed to stay wet throughout the buffing process, and must be used wet to achieve a swirl free finish. Use enough polish so that a thin wet film of material remains over the entire surface after three to four passes with the buffer.

- 3. Begin buffing using medium pressure to remove machine polish swirls. Slowly reduce pressure on subsequent passes to achieve the best possible swirl free finish. After three to four passes with the buffer, remove the film residue using a  $3M^{TM}$  Perfect-It<sup>TM</sup> Detailing Cloth.
- 4. Keep used buffing pad in plastic bag to prevent contamination.

**Note:** If large areas are buffed before removing film residue, use Perfect-It<sup>TM</sup> Final Glaze (PN 06066, 06067) in conjunction with Perfect-It<sup>TM</sup> Hookit<sup>TM</sup> II DA Foam Applicator Pad 6" (PN 05732) to aid in film residue removal.
